• Dr Kevin Wills joins the Board as Executive Director – Exploration [effective 5 June 2017]

Ian Warland ceased to be a Director effective 2 June 2017 [see ASX:MEU 8 May 2017] The Board would like to thank Ian for his contribution which is most appreciated.

Remuneration Details

Dr Rose has agreed to be appointed on a gross remuneration package of less than half of Marmota's pre-existing MD rate of \$175,000 per annum: *i.e.* namely \$85,000 per annum. Dr Wills' remuneration will continue on the same part-time consulting basis as in the past, which has been averaging at around \$6,000 per month over the last 12 months.

Marmota Chair, Dr Rose, said:

"Marmota is highly focused on seeing our shareholder funds targeted into active exploration. We have an exciting gold program ahead of us. With the new structure, I am very pleased that Marmota is able to again see our management and administration costs reduced to industry best practice. Marmota shareholders can look forwards to seeing funds focused on a very active gold exploration year ahead."
